1987

Creation of the Mount Scopus College Foundation

1988 - 1996

The construction of science and art facilities, with the assistance of the Alter, Hansky and Lubansky families. Five modular classrooms were purchased for the Smorgon Family Primary School.

Between 1990 - 1995, \$3,769,000 was distributed to the College for subsidised tuition fees.

As a result of the Gandel Family gift major refurbishment was completed. It included the upgrading of classrooms and science laboratories, expanding of computer facilities, computerisation of the libraries and improvements to the Rose Hall. In appreciation the Burwood Campus was dedicated as the Gandel Campus in 1995.

An extension to the Rose Hall created the Susie and Eric Stock Drama Studio and extended Sport and PE facilities.

1996

The exterior of the buildings at the Gandel Campus were rendered and the grounds at Gandel Besen House were enhanced.

A Masterplan for the future of the College was determined by the College Community.

1997

The Baker Family Cafeteria was completed at the Gandel Campus

The George and Gita Smorgon Sports Complex was completed incorporating the Rita and Sam Kras Basketball Centre, Kras Payes Weinman Recreation Centre, Jenny and Noel Levin Sports Pavilion, Lustig and Moar Aquatic Centre, Margie and Michael Small Tennis Centre and the Jack Skolnik Oval.

1999

Construction of the Besen Family Performing Arts Centre commenced.

2000

The Besen Family Performing Arts Centre, incorporating the Alter Family Auditorium, Baron and Tashi Foyer and Plaza and the Yvonne and Leon Fink Amphitheatre, housing the Eva and Marc Besen School of Music and Susie and Eric Stock School of Drama, was completed and acclaimed by all.

An expanded and redeveloped Fink Karp Ivany Campus was rededicated.

2001

The new Station Street entry, with bus and car park was completed alongside a new Hockey and Soccer Field, and a Mezzuzah affixed to commemorate the new entrance to the Gandel Campus.

Plans were finalised for the Szalmuk Family Early Learning Centre.

A long term, cross Campus Masterplan – Our Shared Vision – results from a new educational structure for the College and the Foundation Executive accepts the challenge to raise the funds for its implementation.

2002

The refurbishment of the existing Szalmuk Family Early Learning Centre is completed and construction of its additional facilities begins.

A comprehensive brief for the Elizabeth and Nicholas Multi-Media and Resource Centre is given to architects.

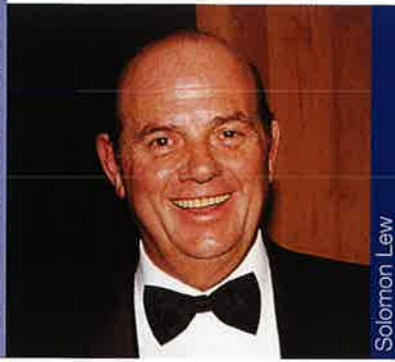

I warmly thank you for your generosity which will provide the resources for Our Shared Vision projects and create a real 'foundation' – by way of an endowment fund – for the future.

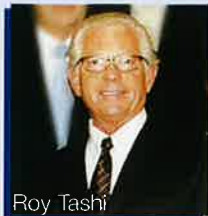

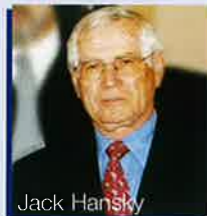

Message from the President

The Foundation events and achievements of the past year will certainly be remembered as exceptional highlights for many years to come.

Who will ever forget the Extraordinary Evening with President Bill Clinton presented to us by Rosie and Solomon Lew? I take this opportunity to thank them again for their warm and generous hospitality and also to acknowledge Rosie's enthusiasm and talent for organising and producing such a special evening.

Last year, when presented with the needs of Our Shared Vision, the College's capital works projects for the next 7 years, the Foundation Executive accepted the challenge to raise \$15 million.

We have been very encouraged by pledges of \$8.35 million towards this new target of which over \$1 million has been collected. I thank you for your unequivocal support which has been overwhelming.

The Executive also recommended, in keeping with the Foundation's original philosophy, that at least 10% of this and any future Campaign would be set aside to build an endowment fund to ensure the College's future financial strength.

Another of our primary goals was to increase the membership of the Foundation to broaden the base of support for the College. Whilst we genuinely thank and value our traditional donors who continue to reconfirm their support, it is with the greatest of pleasure that I acknowledge our 51 new members – both individual and corporate.

It is pleasing to advise, that this year, the Mount Scopus College Foundation became a tax deductible entity, allowing easier management of our activities. I thank Joey Borensztajn for his efforts in this regard.

When Mount Scopus College opened its doors in 1949, our Founders dreamt of a community in which all its children would be able to receive a secular and Jewish education of excellence, regardless of their financial means. Maintaining this philosophy, the College currently spends \$2.5 million every year on subsidised tuition fees, whilst maintaining school fees at a competitive level.

It is predominately because of the success of the Foundation and the generosity of you, our donors, that the College has enjoyed the development of its facilities and educational programs and still been able to maintain subsidies.

None of this would be possible without the exceptional efforts of the members of the Foundation Executive. Solomon Lew's Chairmanship, involvement and concern for the welfare of the College is recognised and appreciated by all. I also acknowledge the outstanding efforts of Sam Alter, Stewart Baron, Joey Borensztajn, Jack Hansky, Michael Karp, Earle Sacher, Nathan Shafir, Roslyn Smorgon, Roy Tashi, College President, Johnny Baker and Director of Fundraising, Marilyn Simon.

The Foundation Executive is now reaching out for additional support for the balance of the funds needed to make Our Shared Vision a reality.

Szalmuk Family Early Learning Centre

This first project of Our Shared Vision has been made possible by the generous support of Mira and George Szalmuk and their family. It will be completed by the beginning of the 2003 school year guaranteeing a great new start for our youngest Scopus students.

The six kindergarten classrooms have been totally refurbished and the mezzanine transformed into publication and consultation rooms. The construction taking place now is creating a reception area, a large multi-purpose Activities Centre and a pergola/Succah to provide a central entry point and flexible space for group activities, celebrations and displays. A Dedication Ceremony early in the new year will celebrate our new look and honour all the benefactors to the project.

There are still attractive opportunities for dedication and recognition in this complex that is vital as the entry point for the majority of Scopus students.

Slezak Multi Media and Resource Centre

The second project of Our Shared Vision is the Slezak Multi Media and Resource Centre on the Gandel Campus. Dedicated in honour of the Bequest of Nicholas and Elizabeth Slezak, it will at least include an enlarged Susie and Norman Rockman Library, an Archive Centre, the Birch Family School of Media Studies, a modern 'Merkaz' and the whole Information Technology Department and its support staff.

The 'user' group and expert consultants have met and determined a most comprehensive brief for the architects. We look forward to celebrating the opening of the Slezak Centre in February 2004 at which time we will be able to show our appreciation to all the donors.

Foundation Endowment Fund

As foreshadowed, the Foundation Executive is mindful that in addition to raising the funds for facilities the Foundation was also established to help secure the College's future. It is the Executive's genuine desire to create a significant corpus which would be invested and only the interest derived would be distributed.

This philosophy has prompted the decision to invest at least 10% of the proceeds of this Campaign into an endowment account. Supporters and Bequestors may also choose this option as the direction for their donation or legacy. When substantial, the interest could fund special programs, provide additional educational resources and staff, maintain facilities and fund subsidised tuition fees.

A sub-committee of the Foundation Executive, comprising, Sam Alter, Stewart Baron, Jack Hansky and Roy Tashi, has been formed to oversee this program.
