“Preferred Language” for Bequests

Bequests should be made to the Mount Scopus College Foundation. The Foundation is a separate legal entity from the College which invests the funds contributed into its Endowment Fund. The income and/or capital may be distributed to specific projects at the College which are of interest to the donor. While a separate legal entity, the sole purpose of the Foundation is to support the goals of the College.

Following is the preferred language to be used in a Will when creating a Bequest to the Mount Scopus College Foundation.

Mount Scopus College Foundation

“I give devise and bequeath free of all duties whatsoever absolutely and beneficially _____ percentage (_____ %) of my real and personal estate whatsoever and wheresoever situate [or, the sum of _____ dollars (\$ _____)] free of all debts (secured and unsecured) to the **Mount Scopus College Foundation Limited** in its capacity as Trustee of the **Mount Scopus College Foundation** of 245 Burwood Highway, Burwood in the State of Victoria and I direct that the receipt of the Honorary Treasurer Secretary or other proper Officer for the time being of the said **Mount Scopus College Foundation** shall be a full and sufficient discharge to my Trustees therefor.”
