History and Objectives

The Mount Scopus College Foundation was established in 1987 to support the Board of Governors and to be the body responsible for major fundraising for the College. Funds raised can be applied to buildings and refurbishment, grounds, tuition fee subsidies, undertaking debt reduction and funding educational programs.

Members of the Foundation include corporations, individuals and families who each have donated a minimum of \$20,000 over a maximum of 5 years since 1987

Classifications of membership are dependent on gift level. They are Members, Fellows, Benefactors, Founders, Trustees and Life Trustees.

The Chairman of the Foundation, since inception, is Solomon Lew. Former Presidents included David Smorgon and Dug Pomeroy. The current President, Henry Lanzer, was appointed at the end of 1996. The goals of the Foundation are pursued by an Executive Committee supported by an Executive Officer - currently Marilyn Simon.

Background Summary

1988 - 1996

Works completed included the construction of another floor of science and art facilities onto the Basser Wing, with the assistance of the Alter, Hansky and Lubansky families.

Five 'state of the art' modular classrooms were purchased for the Smorgon Family Primary School.

Between 1990 and 1995, \$3,769,000 was distributed to the College for

As a result of the Gandel Family gift of \$1,500,000, major refurbishment and development was completed. It included the total upgrading of classrooms, restrooms, and lockers; modernisation of science laboratories; expanding and upgrading computer facilities, computerisation of the libraries and improvements to the Rose Hall.

In appreciation the Campus at Burwood was dedicated as the Gandel Campus.

In 1995 an extension to the Rose Hall created the Susie and Eric Stock Drama Studio and extended Sport and PE facilities.

1996

The exterior of the buildings at the Gandel Campus were rendered and painted and the grounds at Gandel Besen House were enhanced.

A Masterplan for the future of the College was determined by the College leadership, staff and parents. It incorporated the structural improvements

vital for the School's development and growth in the diverse areas of Performing and Visual Arts, Sport, Jewish Studies, Humanities, and Science and Technology.

1997

The Foundation launched its 5 year - \$8,000,000 Capital Campaign to raise the funds for the Capital Works Projects - as determined by the Masterplan. The projects comprised a complete upgrading of all sporting facilities, the building of a 1000 seat Performing Arts Centre, the expanding and improving of bus and car parking and play areas and the creating of a new entrance to the College. The development of the Elizabeth and Nicholas Slezak Multi Media and Resource Centre was also included.

A modernised Cafeteria was completed at the Gandel Campus incorporating a new Kitchen, and attractive indoor and outdoor eating areas.

The George and Gita Smorgon Sports Complex was completed. The Complex incorporates the Rita and Sam Kras Basketball Centre, Kras Payes Weinman Recreation Centre, Jenny and Noel Levin Sports Pavilion, Lustig and Moar Aquatic Centre, Margie and Michael Small Tennis Centre and the Jack Skolnik Oval.

1998

The final plans for the Besen Family Performing Arts Centre, incorporating the Baron and Tashi Foyer and Plaza, and the Alter Family Auditorium, have been resolved with input from the user group and experts in the field.

In response to enrolment demand and demographic changes, plans have been created for the development and expansion of the Fink Karp Ivany Campus.



From the Chairman and the President



It is our pleasure to highlight the activities of the past year of the Mount Scopus College Foundation.

The current Capital Campaign - Total raised to date \$7,851,000


At the fore of the Foundation's present success must be the outstanding results of the current Capital Campaign. The completion of the 5 year - \$8,000,000 Campaign, launched in February, 1997, has been the first priority of the Foundation Executive for 1998. We have continued our process of systematically and professionally approaching current and prospective members and again have appreciated their support. More and more people from every spectrum of Jewish belief - are realising the importance of a successful Mount Scopus College for the continuation of a strong and vital Melbourne Jewish Community.

At this time last year, the Foundation had received term pledges of \$7,000,000. We are pleased to report that over the last twelve months a further \$850,000 has been pledged making a total of \$7,851,000. Of this amount, \$2,861,000 has been collected. More approaches are in progress.

The first of the determined capital works projects, the George and Gita Smorgon Sports Complex, was officially dedicated by the Hon. Alan Stockdale on 7 December, 1997, prior to the Primary School Sports Day. To witness the complete upgrading of all the sporting facilities at the Gandel Campus in 9 months and to know that the cost of \$1,300,000 had been raised and collected is outstanding. The Complex incorporates the Rita and Sam Kras Basketball Centre, Kras Payes Weinman Recreation Centre, Jenny and Noel Levin Sports Pavilion, Lustig and Moar Aquatic Centre, Margie and Michael Small Tennis Centre and the Jack Skolnik Oval. It has been welcomed enthusiastically by the whole school community and will also provide an outstanding venue for the Junior Maccabi Carnival in January, 1999. We take this opportunity to again express our gratitude to all our donors who have made this possible. If you have not yet seen this facility, please avail yourself of the opportunity to inspect the visible evidence of your support, and feel justly proud.

Whilst the Foundation Executive has concentrated on raising the funds for our second project, the Besen Family Performing Arts Centre, the College staff, Finance and Resource Committee and the architects have been finalising the plans. It was critical that the future needs of the College in this fast developing area of School life were identified and met, and combined with 'state of the art' design and technology. The plans have now received Council approval and have been subject to the tender exercise. The process has been very thorough and time consuming and we appreciate the efforts of

Charles Slucki, Director of Performing Arts, Tony Foster, Chief Financial Officer and Les Jolley from the College; Paul Ramler, College Treasurer, and Phil Weinman, Chairman Building Committee Bruce Joske and Phil Lewis, and Alan Synman of Synman, Justin and Bialek. We look forward to sharing the plans with everyone, to the commencement of works, and to inviting you to a Ground Breaking Ceremony shortly. The Besen Family Performing Arts Centre will be a most exciting addition, not just to the College, but to the entire Melbourne Jewish Community. The project also includes an Amphitheatre, landscaped play areas, upgraded car and bus parking and the new entrance to the College.



The Besen Family Performing Arts Centre will incorporate the Baron and Tashi Foyer and Plaza, and the Alter Family Auditorium. The Susie and Eric Stock School of Drama will be expanded to meet the increasing demand for this subject. The complex will be in constant daily use for teaching, productions, rehearsal, events and functions. The whole College looks forward to its completion in 1999.

The Elizabeth and Nicholas Slezak Multi Media and Resource Centre is the project that will follow. The user group for this facility is now coming together to determine future student and staff needs and to create a comprehensive brief for the architects.

Fundraising Strategic Review

Although we have virtually attained the original target of this Capital Campaign, we believe that the Foundation must now put the requirement for additional funding onto its agenda.

The school is enjoying renewed popularity and there are student 'waiting' lists at many levels. Demand is extremely heavy at Gandel Besen House and Fink Karp Ivany Campus which augurs well for the future. In response to demand and changing demographics, 1999 will see the expansion and upgrading of Fink Karp Ivany, which will provide more places for junior students close to their homes.

As the body responsible for the major fundraising for the College, we must extend our goals once again. We are fully aware that there is still much to accomplish and that it is necessary to elevate fundraising for the College in general. Regardless of the amount of money raised by fundraising, the College continues to provide subsidised fee tuition to the total of \$2 million annually for nearly one quarter of its students - as highlighted in this year's Annual Appeal literature.

A Strategic Review of the success of this current Capital Campaign has also served to highlight the areas in which we can improve if we are to continue to provide quality Jewish and Secular education for all our pupils; along with outstanding facilities. We also believe that Programs such as Ulpan should be available to every student and this will only eventuate by sponsorship or external funding.

The whole Community, not just the current parents, must take responsibility for the principle of a 'Jewish Education for all' and be prepared to add their commitment to our fundraising efforts.

It must be the combined responsibility of the College leadership and Foundation Executive to examine the potential of increased fundraising from areas including wills, bequests and endowments, and corporate sponsorship, as well as to maximise the results from existing avenues.

We must be willing to pursue new initiatives and to invest in structures and staff that will allow for the development of such programs. It is not beyond this Community to raise our annual budgeted fundraising target from \$350,000 to \$1 million.....beyond the amount already earmarked for Capital Works Projects.


Annual General Meeting
