# SZALMUK FAMILY EARLY LEARNING CENTRE

It was a privilege, early in 2003, to officially honour the commitment and generosity of Mira and George Szalmuk and their family, when the College dedicated the completed 'Szalmuk Family Early Learning Centre'.

Situated in East St Kilda, it is Mount Scopus' largest kindergarten complex. The existing facility has been completely renewed to offer modern, fully resourced classrooms and extensions include a large Activities Centre, welcoming lobby, publications and communications centre, interview areas and a pergola which became its Succah for the first time this year.

The celebration began with a Kabbalat Shabbat and formalities continued over lunch in the new Activities Centre. Foundation Chairman, Solomon Lew, saluted the largesse and the vision of the Szalmuk family, and the truly pro-active way in which they had assisted Mount Scopus to achieve its dreams. He also acknowledged the longstanding support of the Shafir family and thanked them for dedicating the fifth of the modernised classrooms.

Johnny Baker, President and Michael Danby, OC '72 and MHR for Melbourne Ports unveiled the dedicatory plaque before Rabbi Ralph Genende, the Szalmuk family, and Henry Lanzer, Foundation President, placed a Mezzuzah on the door.

In his moving response, George Szalmuk remarked "that one thing that cannot be taken away from a person is education. As Mount Scopus College is one of the few schools that subsidises students, the Szalmuk family took the decision to help establish the early learning centre, in order to give the community the possibility of the best education, starting from the very beginning of a child's life."



I thank G-d that he has allowed my family and I, to give something back to the community, and I hope and pray that the community will benefit."

The original kindergarten complex was completed in 1982. Supporters to the initial project included Myra and Godfrey Cohen, Judy and Solly Joss, and in memory of David Klamberg and Max Pascoe.

# SLEZAK MULTIMEDIA AND TECHNOLOGY CENTRE


In the 'Information age', a good education requires an extensive knowledge of today's rapidly developing information technologies. Information resources, libraries, multimedia facilities and the like must be geared to a constantly changing world. By bringing the entire Information Technology Centre, School of Media and the Library into one modern facility, the College recognises the complementary interaction and integration of all these resources.

The existing structure will be increased by 30% in size to be a distinctive presence in the midst of the Secondary School on the Gandel Campus and will house:

- O An expanded Susie and Norman Rockman Library
- O Computer and Information Technology Centre
- O Birch Family School of Media Studies
- Merkaz Centre for Department of Informal Jewish Education

The Elizabeth and Nicholas Slezak Multimedia and Technology Centre was dedicated in 1996 in honour of the generous Bequest of the late Elizabeth and Nicholas Slezak and with gratitude to the Trustees of their Estate

The Slezak Centre will commence in November and is due for completion in 2004 with a budget of \$3.2M.

## 'MERKAZ' ('CENTRE')

GROUND FLOOR


The Nerkaz is made up of flexible informal and formal spaces plus offices, fronting the quadrangle for the Department of Informal Jewish Education and Leadership . It will be a modern, informal place for meeting, planning and learning in a convenient location for all students.

## INFORMATION TECHNOLOGY CENTRE

This centre is comprised of five flexible classrooms, each containing a teaching space and clusters of computers, scanners and printers. The classrooms are located around an Open Access Area where students may independently pursue computer based research.

#### Features include

- Five fully integrated technology driven classrooms nearly a third larger in size than normal to enable separate teaching areas for both practical study and theoretical study. They will be used for every subject right across the curriculum.
- Each classroom will cater for 30 Personal Computers which are directly wired back to the building's own dedicated server room, connected by way of a 'state of the art' fibre optic cable to the school's main computer server room.
- Each room has a specially designed lighting system to minimise glare from the computer screens to provide a more efficient and effective workspace.
- Digital projectors interlinked with the computer network and controlled from a specialised panel will be installed in each classroom
- A vast open Resource Centre occupies the core of the building, where students from all year groups can have individual access to a computer linked to the school's Internet and Intranet facilities. The Resource Centre will be supported by a full time help desk and teaching staff to assist in resolving any problems whether they be of a study or a technical nature.
- Separate office spaces to meet the needs of support and development staff.



# MULTIMEDIA AND TECHNOLOGY CENTRE



## FIRST FLOOR

## SUSIE AND NORMAN ROCKMAN LIBRARY

The expanded Susie and Norman Rockman Library incorporates:

Three private study areas where students can either study or participate in small specialised classes.

 A dedicated teaching space where students can combine the use of the library resources with the Internet, whilst being part of a classroom environment.

- An enlarged open library area with an open and uncluttered feel.
   Two skylights, which combined with a vast amount of internal and external glazing, will disperse a large amount of natural light.
- A designated casual reading area, positioned beside a glazed wall facing the oval with comfortable seating. In fine weather, this can be expanded to include a balcony area.
- An additional 16 personal computers and 4 resource computers spread throughout the library will enable students to access all the resources available.
- The ability for personal laptops to be wirelessly connected to the Internet.

## BIRCH FAMILY SCHOOL OF MEDIA STUDIES

Strategically located this Media School contains three editing suites, one of which is directly linked to the studio, to enable students a 'real life' experience of media production. It is designed to cater for a wide range of media/technology related functions with its own dedicated entry providing an isolated area away from the noise of normal school life.

#### It includes:

- Audio Visual recording and editing facilities, where multi channel video and audio recording and editing can be undertaken under the guidance of a full time technician.
- Dedicated secure storage and distribution centre where students and staff can access a wide range of recording and filming equipment.
- Student Radio facility which will enable broadcasting by students to the quadrangle.
- A technology maintenance room where all equipment will be maintained and serviced, and where students can gain some 'hands on' experience into how the equipment works.
- Television Studio and associated control room with its own lighting and camera systems where students can gain first hand experience at television production in a dedicated, specially designed acoustic friendly environment.
- Three separate edit suites with a myriad of uses as the control room for the TV Studio or as audio-visual edit suites, where computer based dubbing or editing of material can be carried out; or as the control room for the radio station. All are isolated by specially designed acoustic treatment.

#### MOUNT SCOPUS COLLEGE FOUNDATION

The Mount Scopus College Foundation was established in 1987 to be responsible for major fundraising for the College. Funds raised can be applied to capital works, endowment, tuition fee subsidies, undertaking debt reduction and programs.

Members of the Foundation include corporations, individuals and families and classifications of membership are dependent on aift level.

Through the generosity of its members, the Foundation has raised in excess of \$26,000,000 for the College since 1987.

Foundation funds over that time have predominately funded capital works projects and fee relief programs. The current campaign for 'Our Shared Vision' - shared with the College - incorporates campus renewal, the creation of a substantial Endowment Fund and core debt reduction.

The Chairman of the Foundation, since inception, is Solomon Lew and the current President, Henry Lanzer, was appointed in 1996. The goals of the Foundation are pursued by an Executive Committee supported by an Executive Director, currently Marilyn Simon.

#### **FOUNDATION HIGHLIGHTS**

Creation of the Mount Scopus College Foundation

Construction of science and art facilities, with the assistance of the Alter, Hansky and Lubansky families. Five modular classrooms purchased for the Smorgon Family Primary School.

\$3,769,000 distributed to the College for subsidised tuition fees.

The Gandel Family gift provided for major refurbishment including the upgrading of classrooms and science laboratories, expanding of computer facilities, computerisation of the libraries and improvements to the Rose Hall. In appreciation the Burwood Campus was dedicated as the Gandel Campus in 1995.

Creation of the Susie and Eric Stock Drama Studio, extended Sport and PE facilities

Exterior of the buildings at the Gandel Campus were rendered and the grounds at Gandel Besen House enhanced.

A Masterplan for the future of the College was determined by the College Community.

The Foundation launched its '5 year - \$8,000,000' Capital Campaign.

The Baker Family Cafeteria was completed at the Gandel Campus.

The George and Gita Smorgon Sports Complex was completed incorporating the Rita and Sam Kras Basketball Centre, Kras Payes Weinman Recreation Centre, Jenny and Noel Levin Sports Pavilion. Lustig and Moar Aquatic Centre, Margie and Michael Small Tennis Centre and the Jack Skolnik Oval.

The Besen Family Performing Arts Centre, incorporating the Alter Family Auditorium, Baron and Tashi Foyer and Plaza and the Yvonne and Leon Fink Amphitheatre, housing the Eva and Marc Besen School of Music and Susie and Eric Stock School of Drama, was completed.

An expanded and redeveloped Fink Karp Ivany Campus was rededicated.

The new Station Street entry to the Gandel Campus, bus and car park was completed alongside a new Hockey and Soccer Field.

A long term, cross Campus Masterplan – Our Shared Vision – is developed and the Foundation Executive accepts the challenge to raise the funds for its implementation.

The refurbishment of the existing Szalmuk Family Early Learning Centre is completed and construction of its additional facilities begins.
